## Reduce, Reuse, Recycle Bearing the Responsibility

"Some went down to the sea in ships, doing business on the mighty waters...."

Psalm 107:23-24

Humans have done business on God's mighty oceans for millennia, using it for transportation, taking its fish for food, and more recently drilling under the ocean floor for oil and gas.

On April 20, 2010, the Deepwater Horizon oil rig exploded, killing eleven workers and injuring dozens more. In the weeks that have followed, millions of gallons of oil have continued to gush into the Gulf of Mexico from leaks in the damaged well.

The oil spill has now reached wetlands along the Gulf Coast, and many on the coast wonder how long this economic and environmental disaster will continue. Fisheries managers have closed some state waters, and much of the federal waters in the Gulf are closed to fishing. Those waters are not likely to re-open soon, and it may be some time before consumers trust the quality of seafood from the Gulf. The economies of the Gulf Coast communities, many of which were only just beginning to recover from the devastation of Hurricane Katrina, will likely feel these impacts for years to come.

"And God said, 'Let the waters bring forth swarms of living creatures, and let birds fly above the earth across the dome of the sky.' So God created the great sea monsters and every living creature that moves, of every kind, with which the waters swarm, and every winged bird of every kind. And God saw that it was good. God blessed them, saying, 'Be fruitful and multiply and fill the waters of the seas, and let birds multiply on the earth" - Genesis 1:20-22

God's creatures will also suffer as the oil inundates their habitats. Endangered sea turtles, migratory birds, fish, shellfish and marine mammals such as dolphins will suffer as their habitats are coated in thick oil. State and federal wildlife officials are working to mitigate the damage, but many will not survive.

Fragile coastal wetlands, already disappearing at an alarming rate, will take another hit. These wetlands not only provide habitat for birds, fish and other wildlife, they also provide critical flood protection for coastal cities during the hurricanes and other storms.

The devastating news we see on television and in the newspapers may make us wonder. What can we do to help the people and places of the Gulf Coast to weather this disaster and begin to recover? We can look for opportunities to help in the clean-up effort and provide assistance to those who are suffering the economic consequences of the oil spill. We can pray for the Gulf, its communities and all of God's creation. We can advocate for better safety standards for offshore oil drilling rigs, more liability for oil companies that fail to meet them, and long-term economic aid to help the Gulf Coast survive this disaster and begin to rebuild.

But each of us bears some responsibility for what is occurring on the Gulf Coast. Each of us, when we drive a car, take a plane, or throw away a plastic bottle, makes up a small part of our nation's massive consumption of, and dependence on, oil. We can see the consequences of that addiction in the images on our television screens, and we can pledge now to try and change our patterns of consumption, to think before we buy a bottle of water or take an unnecessary trip to the grocery store.

And as the disaster continues to unfold, you can keep asking yourself, "Am I doing all I can to ensure that this never happens again?"

## Oil Spill Update, June 10, 2010, Elca Disaster Response

Sisters and Brothers in Christ,

We continue to monitor the devastating oil spill in the Gulf of Mexico and pray fervently for all those who have been affected. Indeed, while the long-term effects of this tragedy will be felt by all of us, for those whose lives and livelihoods have been directly impacted, the needs for help are acute and overwhelming.

We have received numerous inquiries from Lutherans around the country about volunteering in some capacity along the Gulf Coast. At this moment, only people who are being specifically trained and equipped by BP are being permitted to work directly in the clean-up process. This has much to do with the health and safety risks of handling the crude oil. In the future, opportunities may emerge for other types of volunteer roles, and each state in the area - Louisiana, Mississippi, Florida, and Alabama - is receiving names of volunteers who are interested in helping.

Several questions have been raised about whether a national funding appeal should be launched in response to this tragedy. Our commitment has always been that we will find the most efficient ways possible to use financial contributions to meet unmet needs that arise from disaster. At this time, BP has pledged that it is their responsibility to pay for all costs related to clean-up as well as to reimburse those who have experienced a loss of income as a result of the spill, and anyone seeking to file a claim can do so directly through the BP Website. Given the unique nature of this situation, we will not be seeking funding for this response.

Instead, we lift up the unfolding needs of those in the many states affected by flooding and tornadoes so far this spring, most recently in Ohio, Michigan, and Illinois, and I ask you to consider giving a gift to support the responses underway in Yazoo City, Mississippi and Nashville. Tennessee.

In the meantime, we will continue to listen for emerging unmet needs along the Gulf Coast and for meaningful ways that we might engage there. As we do, I ask for your continued prayers for the beautiful land and people of the Gulf Coast as they struggle to overcome this continuing tragedy.

## Ministry Guardians Meeting of June 10<sup>th</sup>, 2010

This was a mutual meeting of the Ministry Guardians and the Ministry Leaders. Those present as Guardians: Mike Bing, Lisa Brooks, Michael Murray, Chris Laux, Nancy Snyder and Pastor Doug. Those present as Ministry Leaders: Janis Marhenke, Jeff Hammett, Dawn Armstrong, Ruth Lindsey, Marilyn Baker and Barb Hoover.

The meeting was opened with prayer and a devotional exercise based on Ephesians.

Chris Laux then turned the meeting over to Dawn Armstrong and the Ministry Leaders agenda:

1-After discussion, it was noted that better communication was needed between the Guardians and the Leaders and that they should meet together two to three times a year. It was also decided that the Ministry Body needs to be made aware of who is on each group and what the duties and responsibilities are. Future newsletters will include a section each month that explains to the Ministry Body some aspect of the Church structure so as to help educate the members about how the structure works and who they should contact with any questions, comments or issues.

2-How are we going to welcome and integrate Ginger? It was resolved that everyone at St Paul is excited about Ginger joining us and the all the Guardians and Ministry Leaders will make an effort to assist her in any and all ways necessary to help her and make her feel loved and wanted. A reception will be held at 9:30 am on Sunday July 11<sup>th</sup> in the community room. The purpose of this reception is to allow more members to meet Ginger for the first time. Mike Bing will be in charge of the reception.

3-A retreat for the Guardians and Leaders will be held on February 18<sup>th</sup> and 19<sup>th</sup> 2011 at a site to be determined. Some discussion was held on what the agenda will be for that retreat.

4-Ruth Lindsey gave an overview of the Church's financial status. Ruth's conservative estimate was that we will finish the year in the black, but possibly with less carry over than in 2010.

5-Discussion was held concerning how more team ministry can be started and encouraged. Dawn will continue to explore this issue and one avenue will be to publish ministry opportunities in the bulletin and newsletter for the members. Pastor Doug reported that he and Janis Marhenke as Faith Encouragers have come up with a design for faith teams and hope to have the program rolled out by September.

6-Discussion was held concerning how the Church Leaders should resolve large issues. It was noted that communication is still the key. It was also decided to assist any Ministry Leader with any large issue by having at least one Guardian involved to help and support the Leader.

After praying the Lords Prayer, the Ministry Leaders left the meeting and the Guardians continued.

Pastor Doug moved to accept the minutes from the May 6<sup>th</sup> Guardians meeting, Nancy Snyder seconded and the motion was approved.

Mike Bing moved to accept the treasurer's report for May, Pastor Doug seconded and the motion was approved.

#### **OLD BUSINESS**

Michael Murray is still gathering information about the kitchen remodel. It was decided that Michael and Jeff Hammett would meet to go over the project and then have one or two open meetings open to all members interested in the project. After all members have the opportunity for input, an initial draft of the proposed remodel will be brought back to the Guardians.

The purchase of an AED with memorial fund money was approved by the Endowment Committee and the unit was ordered.

The remaining staff evaluations will be completed by Pastor Doug and Chris Laux, hopefully before Pastor leaves on vacation.

The ministry team in charge of the 125 year celebration will be meeting soon.

It was reported that both the meet and greet for Ginger and her family and the Meet the Family event were very well done and received by those attending.

Michael Murray has reported that to this date he has had one member volunteer to help with the Church's web site. Michael was given permission by the Guardians to use the lap top left from the Saturday Night Alive worship service to help in updating and maintaining the web site.
